

Object No.042

Reality Warping Glass

Assessment : **Easy**



Overview

Object No.42 is a full body mirror with a height of **5** inches. While ordinary in appearance, it's anomalous effects are shown when a subject, ranging from organic beings to ordinary household items, is placed in front of the mirror in full, Where it is suspected their new form will be reflected to them (judging by the reactions of subjects from previous incidents and

experiments) while they are frozen in place. Note that no one other than the subject seems to be able to view the target's reflection. General scenery remains unaffected. Experiments have shown that minor exposure such as a hand or face being reflected will not trigger **No.42's** transformative effects. In short, as long as nothing is reflected fully, **No.42's** abilities have no effect.

Effects

No.42 alters whatever is caught in its mirror reflection into a random form but most results from experiments and incidents indicate it favours humiliating end results. Examples range

from promising individuals with a clean background record being reduced to their polar opposites (i.e female doctors being turned into street whores, professional bodybuilders warped into skinny nerds etc etc) to nuclear warheads being turned into high quality vibrators. Individuals warped by **No.42** have been noted to undergo differing levels of mental changes ranging from complete identity loss to slight vocal altercations. Ultimately, the mental changes seem to be dependent on the physical transformation. Pictured to the right is the final result of the incident and the case that alerted the Society to the existence of **Object No.42**. Designated **Subject F-042-001-A, 1-A** for short, used to be a well built tomboy who was part of a group of urban explorers venturing through an abandoned mall complex after multiple disappearances (now attributed to **No.42** until confirmed otherwise). She was separated from her group and after sifting through security camera footage of the mall set up by local police, ended up finding **No.42** in an unnamed clothes store, its logo long since decayed. The moment **1-A** stepped into view of the item, the



subject froze in place for up to **5** seconds before she quite literally blipped out of existence, replaced with a bodacious woman dressed in a tight tank top and short shorts that served to expose and highlight her now mature body, complete with a bright pink apron. The camera is also affected, changed into a large circular tray a waitress would use in a cafe or restaurant, now classified as **Subject 1-B**. **Subject 1-A** is noted to be quite outgoing but very reserved when it comes to her lack of feminine traits according to interviews with the rest of the group who went to the police to lodge a missing persons report. A man going by Thomas in the group was seen to be very worried in reaction to **1-A's** disappearance, noting **1-A's** excitement for being the

representative for her country in the marathon next week. He was willing to provide a photo of her during training the day before the incident (see above left image). In contrast, the person our recovery team detained alongside **Object No.42** was noted to be quite ditzzy in nature, speaking in a valley girl accent with rudimentary vocabulary, walking with a gait that showed off her wide hips and massive cleavage and constantly trying to get members of the recovery team to grope her or saying she'd be "more than glad to cook them all a meal once we get home". She is now currently attached to one of the senior members of the team; Adam, who updates the report a few weeks into the stay with notes of her being an excellent cook, housewife and a welcome sight to see in bed after a long day at work. **Subject 1-B** is noted to be constantly used by **1-A**, from a food tray to a prop in her sexual antics with Adam, who leaves an additional sticky saying she's probably the most submissive woman he's ever known, further contrasting **1-A's** previous demeanour before being warped by **No.42**.

Storage

No.42 is stored in a pure white room with a dust cover placed over it, with lighting inlaid into the construction of the room to offset its abilities when the dust cover over it is removed for experiments and routine checks, any personnel entering must do so while wearing special gear made to blend in with the rooms appearance so as not to trigger the items effects. Checks are to take place at the end of every **5th** day of the week to assess the condition of the mirror and whether its effects have any changes.

Listed below is a summary of an experiment with **No.42**.

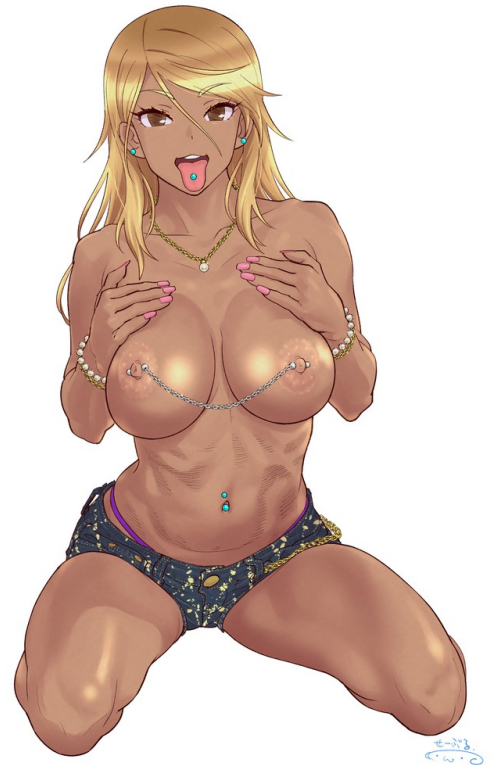


Experiment 001-A

Subject : F-042-029-A

Experiment begins as **2** suited personnel escort **Subject F-042-029-A** (**29-A** in short) into the room, unlocking her restraining device before swiftly exiting the room. **29-A** is a fit woman in her thirties, showing signs of regular fitness being maintained, with

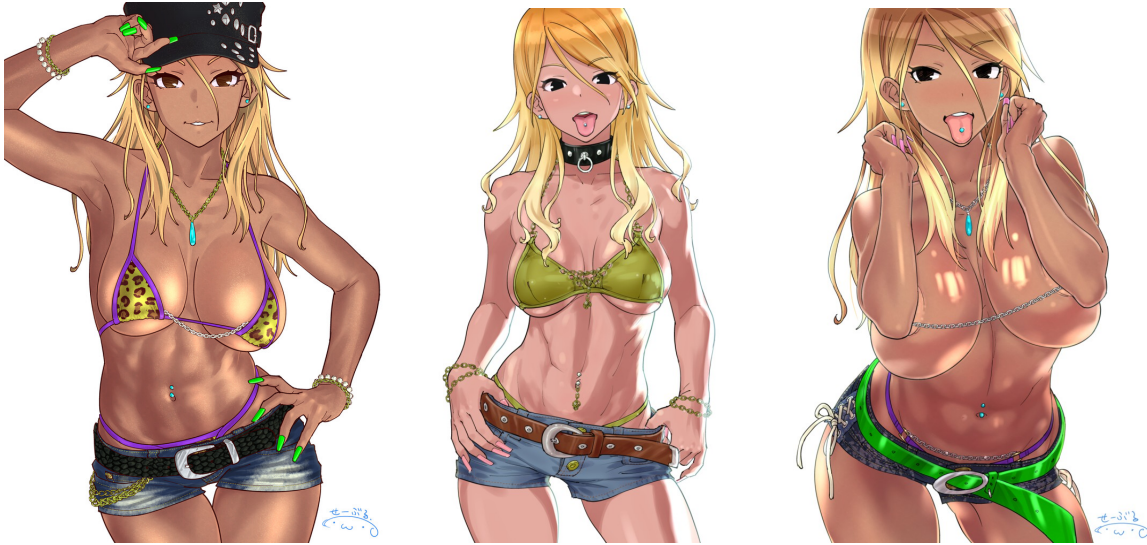
dyed purple hair and a sickly pale skin tone, arrested under charges of drug trafficking and running a local gang in the nearby town (picture to the left, shot as subject leaves her vehicle before being apprehended). A speaker directs the subject over to the item in the middle of the room, instructing her to remove the cover and tell them what she sees. After a brief spat of derogatory terms and insults by the subject, **29-A** removes the cover, she begins to describe **No.42** in a bored tone after a sudden look of disbelief. As **29-A** steps into range of **No.42's** mirror. Her description of the item stops as she freezes in place as her eyelids widen as if she sees something in the mirror before undergoing the same blip effect **1-A** went through. **Subject 29-A** now appears as a slim, tanned girl in her late teens wearing nothing but garish short jeans and a revealing pink thong tightly hugging her hips. Her body is now adorned with various piercings and jewelry in addition to sporting larger breast size (noted to be an increase from an A cup to D) with her previously tied dyed hair bow being an unkempt mess of naturally dirty blonde hair, her face still frozen in shock. The dust cover has been noted to have been turned into a tank top with similar patterns to **29-A's** new attire, designated **29-B**, it is later returned to her following the after experiment report and interview. Returning to the scene, **Subject 29-A's** expression changes and she falls to her knees as she sees the guards enter. As the men drag the subject out, they have to keep her restrained as she repeatedly attempts to claw at their lower regions, her now sharp manicured fingernails threatening to tear through the material and expose the guards to the effects of **No.42** (request sent for stronger material in the suits). **Subject 29-A** is taken to a holding cell nearby and interviewed, straight off the bat the most noticeable change besides the physical and mental is her speech pattern, going from gruff and masculine to vapid and slang terms for various terminology her new self cannot comprehend. Results of the interview show that she has no memory of her criminal past and when questioned on what she can remember, simply states that she can "provide it right now for a price" as camera footage shows her making sexually suggestive motions with her hands. Compared to her previous self, who led a life of hardship from abusive parents to making it to the top of the local criminal



network, all that's left after the warp is a prostitute whos been in the business as long as she can remember, disturbingly making emphasis on a "daddy" (from her records before being transformed by **No.42** the abusive family life is mostly attributed to her father) during the interview. She was given **Tier-1** amnestics that guarantee no memory of her time in the facility will remain and released by Cleanup Crew Alpha, dropping her off in an alleyway near her "workplace" mentioned during the interview. The images below are various shots in a locally produced pornographic magazine containing shots of **Subject 29-A** ranging from **1** week after the interview to an estimated **6** years. At least confirming no relapse in memory or behaviour of subjects previous memories before their change, **Subject 1-A** has married Adam and is now about a month or so into pregnancy and has undergone a dramatic change in appearance, falling deeper into her new life as loving housewife, Adams attached photos of his life with **1-A** are below...
