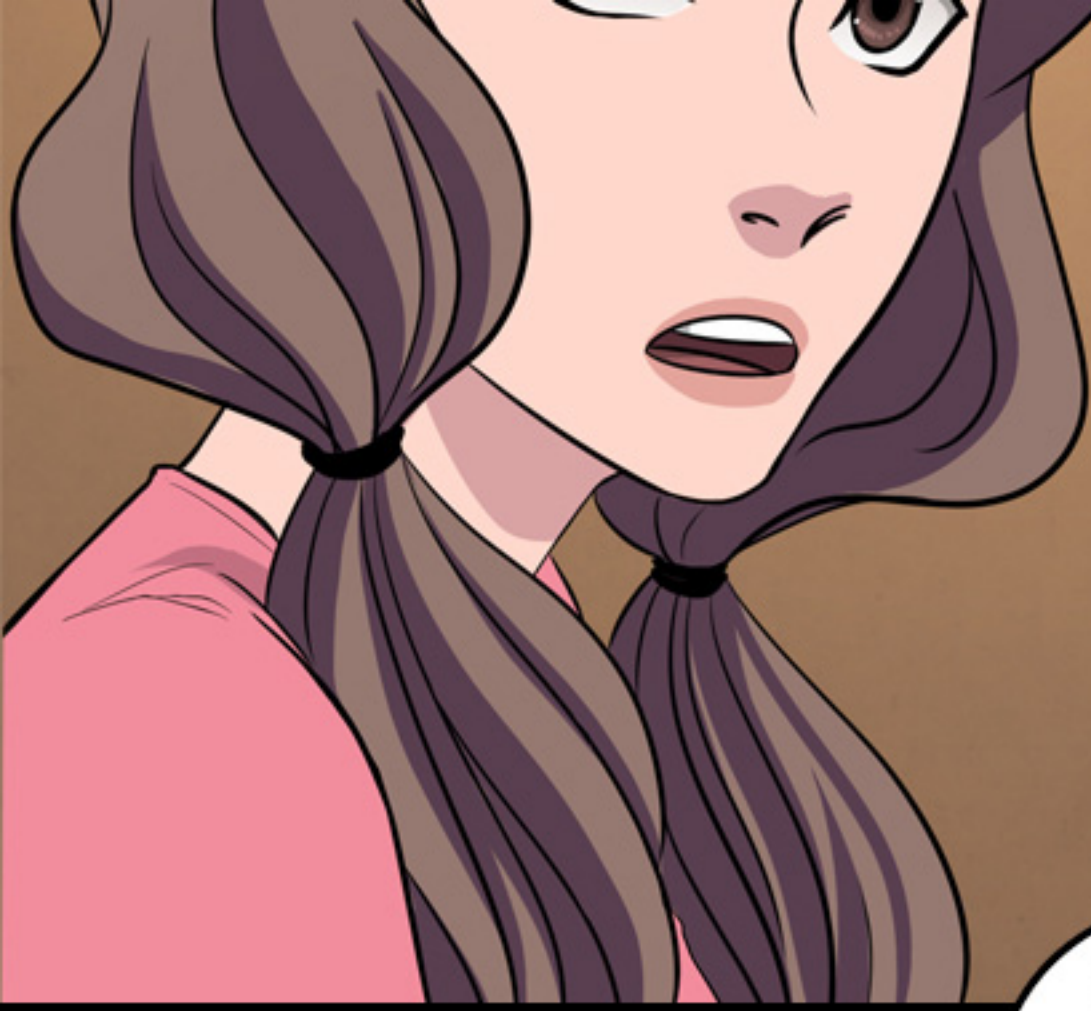
THAT'S THE

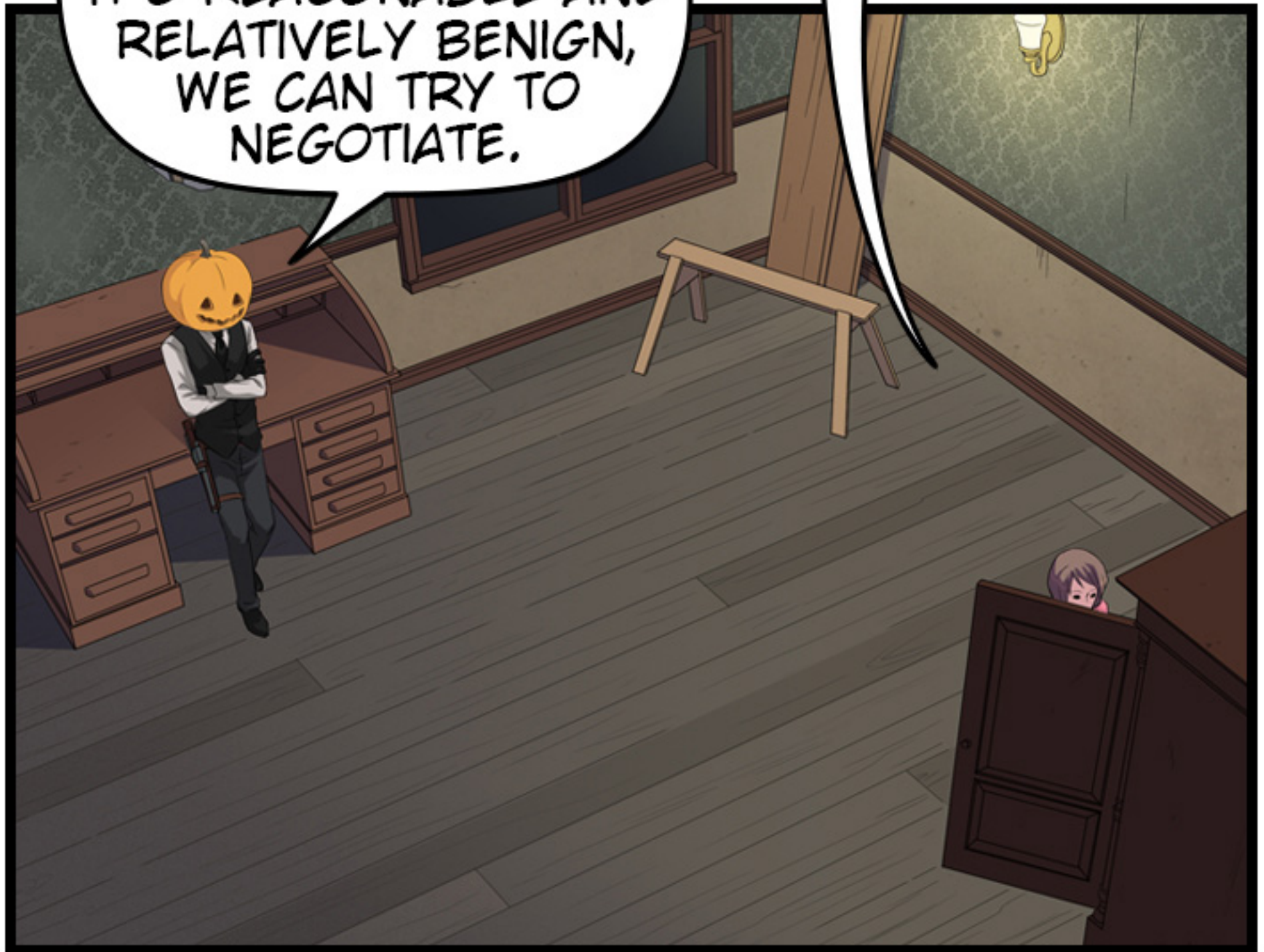






SO IF THERE

PRESENCE...

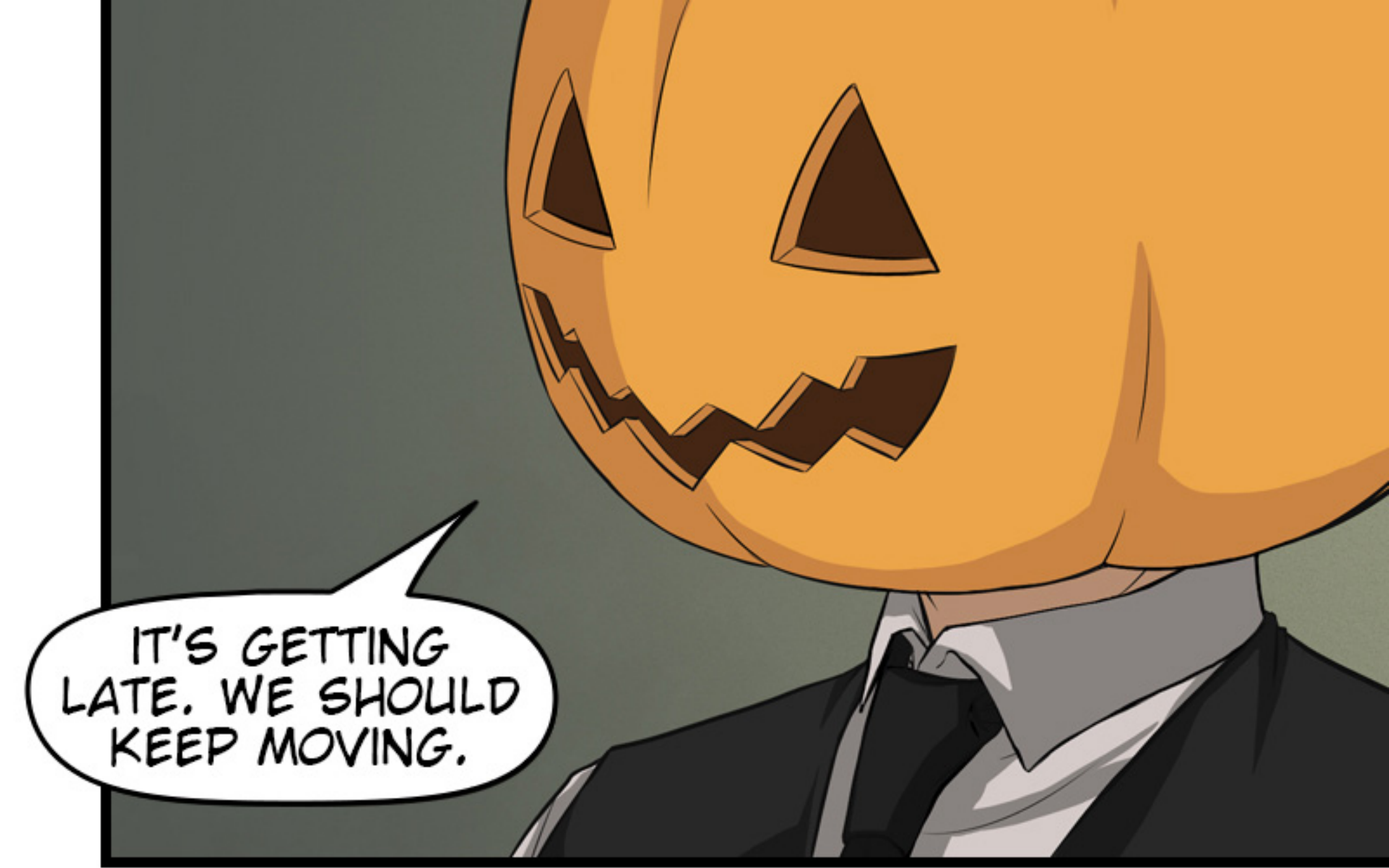

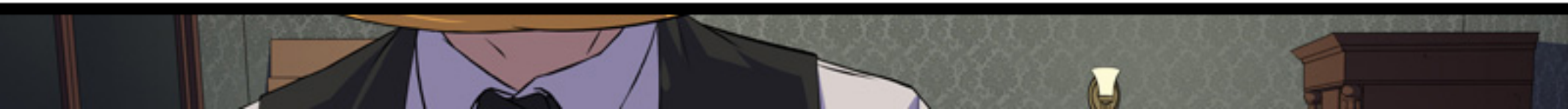
